[Venture Validator 1.0](#) is FREE, open to all. Aspiring entrepreneurs meet once a week for three weeks to test out their new business concepts. With the support of seasoned mentors and coaches, participants conduct customer discovery and market research, create a business model, analyze their competitive landscape, and prototype products with the goal of launching successful ventures.

[Venture Validator 2.0](#) is a continuation of your customer discovery journey and digs into market opportunity for your business idea. Venture Validator 1.0 is a pre-req for 2.0.

[Venture Jumpstart](#) is a self-paced, modified accelerator focused on providing the tools entrepreneurs need to succeed, whether that's pre-built financial templates, industry connections, or an encouraging community here to help build and grow your business.

Rural Energy for America Program (REAP) Funding Available

USDA Rural Development has grant funding available to help agricultural producers with renewable energy or energy efficiency improvements through our Rural Energy for America Program.

Grant funds for up to 50% of the total project costs are currently available for installation of renewable energy systems and energy efficiency improvements for agricultural producers and rural small businesses.

Applications for the [Rural Energy for America](#) are accepted anytime, with a final upcoming deadline of March 31, 2025.

Agricultural producers with at least 50% of their gross income coming from agricultural operations can apply for REAP; they can be located in rural or nonrural areas. Small businesses that are located in an eligible rural area are also eligible to apply.

[REAP Renewable Energy System \(RES\) funds](#) can be used for systems such as:

- Small and large solar or wind generation
- Geothermal for electric generation or direct use
- Hydropower below 30 megawatts
- Biomass (for example: biodiesel and ethanol, anaerobic digesters, and solid fuels)

REAP Energy Efficiency Improvement (EEI) funds can be used to buy, build, and install EEI such as:

- Electric, solar, or gravity pumps for sprinkler pivots
- Switching from a diesel to an electric irrigation motor
- Lighting, Insulation, Doors, Windows, Cooling or Refrigeration units
- High-efficiency heating, ventilation, and air conditioning systems (HVAC)

Community Facilities Loan & Grant Program

The USDA Community Facilities program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial, or business undertakings.

More than 100 types of projects are eligible for Community Facilities funding. Eligible applicants include municipalities, public bodies, nonprofit organizations, and federally recognized Native American tribes. Projects must be in rural areas with a population of 20,000 or less.

Colorado Business Builder Grants

The Northwestern Rocky Mountain Regional Food Business Center Colorado team is offering grants of up to \$10,000 to support small to mid-scale Colorado food and farm businesses. \$200,000 total is available for this program, and we expect to make between 20 and 60 awards. Awards will be announced at the end of February 2025, with the expectation that funded work will be completed within 8 to 12 months.

This Small Grants program is one of two Colorado Business Builder grant programs that will award a total of \$500,000 through July 2027.

Your Colorado-based farm, ranch, or value-added food business may be eligible. The program is for small and mid-scale businesses that are producing in, sourcing from, and focused on local and regional markets, or serving multiple small- and mid-scale food and farm businesses. Grant funds are intended to improve business skills, strengthen the viability of your business, expand your access to markets, or strengthen local and regional food and agriculture supply chains.

December 2024 REDI report Irrigators' Perspectives on Water Management and Adaptation in the San Luis Valley

Key Findings

San Luis Valley Producers:

- Decisions are driven by both yield/profit and impact on future generations
- Are more sensitive to policy changes than to drought
- Prefer to change technologies rather than crops
- Are divided on whether current groundwater rules have a positive impact
- Agree that current groundwater rules are legitimate and are being followed
- Believe that current groundwater rules have a disproportionate impact on certain groups

- Support a broad variety of policies to manage groundwater

Economic and Community Contribution Analysis of the Forest Product Industry in Colorado

Nara Chung, Derek Lowstuter, Timothy Reader, Anita Alves Pena

Key Findings

- The forest product industry in Colorado is innovative and provides various economic and ecological benefits.
- The contribution of the forest product industry in terms of output and value added is over \$6,088M (0.59% of total state output) and over \$2,843M (0.49% of state GDP) respectively.
- The estimated economic impact of 2024 USDA Wood Innovation Program Grants to the state is 4.71 times larger than the total amount of grants awarded.

The State of Homelessness in Colorado

Luke Maddock

Key Findings

- 4,439 people experiencing homelessness, up from 9,754 in 2013 and 10,940 in 2017
- 150% increase in chronic homelessness over the past decade (1,780 to 4,457 individuals)
- Significant racial disparities: Black/African American (3x), Native Hawaiian/Pacific Islander (14x), and American Indian/Alaska Native (3x) overrepresented compared to general population
- 31-44% of the total homeless population suffer from severe mental illness or chronic substance abuse, and 11% are victims of domestic violence

The Economic Impact of Pathfinder Event Center

Henry Williams

Key Findings

- Pathfinder Event Center provides economic benefits to Fremont County, CO.
- Using input-output modeling and analysis-by-parts, we estimate the economic impact of Pathfinder in 2023 across four metrics to be:
 - Total Output: \$711,591
 - Value Added: \$212,025
 - Labor Income: \$114,829
 - Jobs: 3.9
- By output, the impact of Pathfinder was 3.2 times greater than its budget.
